In order to better promote the development of aesthetic education, cultivate aesthetic talents, and implement the relevant requirements of the Ministry of Education's "Aesthetic Education Infiltration Action", the 5th. International Youth Picture Book Festival (IYPBF) is an international youth art exchange event to be held in China in 2025, organized by the **Beijing Municipal UNESCO Clubs Association**, the **International College of Central Academy of Fine Arts**, the **International Education of Primary and Secondary School Professional Board attached to Beijing Institute of Education**, and the **Experimental School Affiliated to Central Academy of Fine Arts**, with participation of many kindergartens, primary and secondary schools, and institutions at all levels. This year, the theme of this event is "Intelligent Drawing Life - AI (Artificial Intelligence) Endless". **I. Organizational units**

II. Participants

The competition is open to children and teenagers aged 4-18 years old, and is divided into five categories according to the players' conditions:

4-6 age group (pre-school group).

7-9 age group (lower primary school group).

10-12 age group (upper primary school group).

13-15 age group (junior high school group).

16-18 age group (high school group).

III. Activity requirements

1. This international art festival activities are set up in two parts - original picture books (hand-drawn) and AI (Artificial Intelligence) paintings. The submitted works must be the author's original (AI paintings require that the idea is original), unpublished (including all public-oriented media in paper and digital form);

2. With the theme of "Intelligent Drawing Life - AI (Artificial Intelligence) Endless", the exhibition will express the changes of AI on human life through art forms, and the impact of AI on the world, human beings, races and different cultures in the future, how to use AI to serve human beings and improve their learning ability and living standard, and at the same time how to look at the negative impacts of AI on human beings, and objectively and rationally face the rapid development of AI as well as meaningful stories in people's daily life.

3. Requirements for the creation of works: The work is suitable for people of all ages to read and enjoy, content should be positive. Style, presentation methods and forms of expression are not limited.

3.1 Original picture books:

Each age group should create a work of no less than 4 pages (minimum of 4 pages, maximum of 10 pages), narrating a continuous and complete story. Each work should be no larger than A4 in size, and a simple explanatory text can be added at the bottom of the picture at a distance of more than 1cm from the bottom edge, with the width of the work aligned on both sides, and the page number in Arabic numerals should be indicated in the bottom right corner of each page. Picture books can be in acrylic, pencil, watercolour, gouache, ink, marker, oil, line drawing, paper-cutting, New Year picture, printmaking, composite materials and other forms of artistic expression (original picture books must be hand-drawn, and photographic and video works will not be accepted);

3.2 AI (Artificial Intelligence) paintings:

You can use any legal AI drawing programme to draw or generate **a single piece of** artwork, with a creative description of the artwork in the space below. Please submit all artworks electronically, within 21.6cm x 29.7cm, 350dpi pixels, in JPG storage format;

4. Requirements for framing: All works do not need to be framed.

5. How to submit your work:

5.1 Online Submission: All participants are requested to submit and register their original works by taking photos or scanning them and compressing them in the way specified by the organizing committee.

5.2 The size of the electronic version: within 21.6cm x 29.7 cm, pixel requirement:350dpi. Please always submit in JPG storage format;

5.3 Requirements for Submitting works electronically:

*Folder name: age group (e.g. 13-15 age group) + creator's name (ID card or passport name), format example: 4-6 age group LI XIANG

*Attachments in the folder include: electronic zip file of the work created (according to the participation in the picture book, calligraphy or AI painting or all of them) + application form + informed consent (all in electronic form).

*The content of the above documents should be submitted to the organizing committee through the registration system applet.

6. Selection of works:

The organizing committee will organize relevant experts to carry out preliminary selection after collecting all the works, and the preliminary selection will be completed for the selected award-winning works, please submit and send the original physical works (physical works do not need to be framed) to the designated address according to the requirements of the organizing committee after receiving the notification. Please understand that considering the limited manpower of the organizing committee and other reasons, all the electronic or physical works submitted will not be refunded.

7. This event is a public service activity without any charge registration fees, evaluation fees, material fees, etc..

8. Copyright of entries:

8.1 By submitting a work, the participant is deemed to have transferred the rights to reproduce, distribute, exhibit, produce derivatives and other related rights as well as the ownership of the original work to the organizing committee of the event without compensation and irrevocably from the date of submission, and the participant himself/

herself retains the right of authorship of his/her work only.

8.2 The participant must guarantee that the work is created by him/herself and does not infringe upon the legal rights and interests of any third party (including but not limited to: copyright, portrait right, right of honour, right of privacy, etc.). In case of violation, the entry and award will be disqualified. Any legal responsibility arising from the entry or the act of entering the competition shall be borne by the participant himself/herself.

8.3 Participants should obtain the consent of their guardians and have them sign an informed consent form. If the guardian agrees to participate, the guardian is deemed to have agreed to abide by the foregoing terms and conditions.

8.4 In the following cases, the competition organizing committee will make an announcement on the official website and public number of the competition and disqualify the participant:

-Original illustrated works submitted using non-hand-drawn methods;

-Entries using high quality imitations, ghostwriting, or plagiarism of others;

- Participate with works from previous events.

9. During this event, there will also be a charity auction of works (participation in the event to submit works is deemed to be the author agrees to donate his/her works and participate in the charity auction), and the money from the auction will be donated to charitable organization or institutions.

IV. Judging and awarding

1. The evaluation of the awards are divided into net selection, preliminary evaluation and final selection (the organizing committee will no longer accept applications in the name of an individual for any students who have been collectively enrolled in the activity by organizations);

2. Prizes:

2.1 Student awards:

*Starlight Award (equivalent to Special Gold Award)

*Shine Award (equivalent to Gold Award)

*Super-excellence Award (equivalent to Silver Award)

*Emerging Talent Award (equivalent to Bronze Award)

*Excellence Award (awarded to any participant who does not receive one of the above awards)

2.2 Tutor Awards:

*Excellent Guidance Teacher Award: Instruct 10 students in this activity.

2.3 Organizational awards:

*Outstanding Aesthetic Organization Award: Instruct 30 students in the activity.

*Best Aesthetic Education Organization Award: Instruct 50 students in the activity.

2.4 Other awards and certificates:

The winning authors will receive a certificate of "Social Practice Certificate" upon

request.

The organizing committee will hold an opening ceremony and award presentation

ceremony event and invite some of the award-winning students to participate in the event.

V. Submission of works and exhibition time and place

1. Time:

1.1 Deadline for submissions from in China: 30 June 2025

1.2 Deadline for submissions from outside China: 30 July 2025

2. Deadline for registration and collection of works: The deadline for submission of works is until 30 July 2025 when the online registration system closes, based on the time of online submission of works.

3. This year's competition will be held in January 2025, and all applications and submissions will be made through an online platform. The organizing committee of the competition will be announced on the WeChat official account "Experimental School Affiliated to Central Academy of Fine Arts". Please pay attention to the notice on it for specific registration method. The author outside China could send the documents to the email box <u>1187764634@qq.com</u>.

4. Registration is divided into collective registration and individual registration, all please through the organizing committee to provide online registration and process requirements for registration.

5.1 Time of the Opening Ceremony: Sunday, 9 November 2025

5.2 Exhibition address: the Experimental School Affiliated to Central Academy of Fine Arts, No. 10 Dashanzi Xili, Chaoyang District, Beijing, China.

5.4 The time and place of overseas exhibitions and travelling exhibitions will be announced later.



Picture books are books that tell a story or express an idea through the form of pictures.



Each age group should create a work of no less than 4 pages (minimum of 4 pages, maximum of 10 pages), narrating a continuous and complete story.

Attachment B: Shooting Requirements

After completing the creation of original works of picture books, you can use a digital camera or mobile phone to take photos of each page, under sufficient light conditions, and then convert the photos into JPG format to save them in accordance with the requirements of the notice of the event. In order to facilitate the jury to evaluate the awards through the electronic version of the works, please store the photos with a clarity of not less than 350dpi.

1. All preliminary works will be submitted as electronic copies of the original work (including AI-created paintings).

2. Award-winning shortlisted works should mail the original works to the organizing committee designated location within 15 days after receiving the notice of the organizing committee. Late arrival of the work is considered abandoned;

3. No framing is required for original works sent to the Organizing Committee by post.

The participant himself/herself retains the right of authorship of the work only.

In case of violation, the participant will be disqualified from participating in the activity or winning the prize. Any legal responsibility arising from the work or the act of participation shall be borne by the participant himself/herself.
